

The most comprehensive device history check available in the UK

CheckMEND provides a device life history that starts at the point of manufacture, through ownership changes, right up to it being recycled back into its raw components and minerals.

You can perform a CheckMEND check on mobile phones, laptops, tablets, GPS, games consoles and all types of serial numbered devices. The system searches datasets that contain billions of serial numbered items of property and is the most reliable method of ensuring goods are legitimate.

CheckMEND's providers have spent more than a decade building relationships with data providers including the public, police, retailers, recyclers and networks the world over and today is regarded as the authority on the information relating to the sale/purchase of second-hand goods.

How CheckMEND works

The device is checked against IMEI loss and theft reports from over 95 mobile network operators globally, including CDMA data in the US. We check police crime reports from over 15,000 law enforcement agencies in the US and UK, insurers title information and settled claims.

These checks provide information which will flag up (red) in a CheckMEND report if the device is compromised. Further information on a flag can be provided if required, but ultimately a red flag is a clear indication of a compromised device.

CheckMEND answers the questions:

- Could this device be in the wrong hands?
- Am I going to be subject to fraud, or handle stolen goods?
- Could I overpay for this device?





Status change monitoring

For many users who are handling large volumes in a fast-moving environment the status of a device as shown by CheckMEND can change during the period it is held. This can occur if a theft takes time to be reported to police, or a network is slow in effecting a service block.

CheckMEND provides a supplemental service to address that issue which indicates when the status of a device that has previously been shown as “green” turns “red” over a 7-day period.

This is especially valuable to recyclers and reverse logistics providers so they can:

- Potentially recover cash paid for devices.
- Avoid spending time on refurbishment or repair of compromised devices; and
- Not sell these compromised devices on to third parties for whom they may not work.

Where does CheckMEND's data come from?

Data for GSM devices comes directly from networks and from the GSM network operators' trade association.

Police data comes direct to us from individual law enforcement agencies and the US NCIC Stolen Article File provided by the FBI.

Insurance and lease data comes from corporations sharing their data to prevent insurance and finance fraud.

Other data about ownership, loss and theft comes from a variety of services that Recipero provide to retailers, traders and the public.
