Report My Loss

National loss property reporting

Report My Loss is an online service used by thousands of people each month to securely and conveniently submit details of lost property.

Publically available since 2008 Report My Loss operates nationally with the support of many police forces who see numerous operational benefits including improved rates of property repatriation.

Loss reporting ecosystem

When a member of the public creates a new loss report it is placed on a secure database that is part of Recipero's Crime Reduction Ecosystem. The lost item can be searched by police and lost property offices nationally increasing the chances of lost items being identified and returned whilst decreasing the chances of associated criminality.

The loss reporting process;

- A report is submitted online at a time and place convenient to the person making the report.
- Once submitted it is immediately searchable by the police though the NMPR system used by officers throughout the UK.
- Any updates or changes made to the report are also immediately viewable.

- 4. If a lost item is recovered by police, they can quickly identify the owner and return the property.
- In the event of needing to make an insurance claim, Report My Loss certificates can normally be used in place of police loss report references which many forces have already phased out.
